Certified Payroll Manager (CPM)

Leading a team of payroll practitioners, as a Certified Payroll Manager (CPM), is an exciting and rewarding career choice. Many Certified Payroll Managers find themselves solving payroll challenges and designing and building payroll systems for large firms or managing a payroll department including implementing best practices gained through the program. CPM certification can open new doors and opportunities.

In order to enroll in the program you are required to be a Payroll Compliance Practitioner (PCP). The PCP certification can be obtained through courses available at colleges and online, or if you have experience in payroll, through a challenge option. The CPM certification prepares seasoned payroll professionals to manage a payroll department by building on compliance knowledge and developing payroll management skills.

CPM - Payroll Experience Prerequisite

PCP certified members who wish to enroll in the CPM program must meet a payroll experience prerequisite to register. To satisfy this prerequisite, the individual must have at least two years of experience being responsible for an organization's payroll function, which includes being accountable to management for the accuracy of employees' pay and all government statutory remittances, or equivalent experience, obtained in the past five years.


Individuals must submit the Payroll Experience Prerequisite Application and receive approval from the Canadian Payroll Association prior to enrolling in the Introduction to Payroll Management course. Please allow 20 days for the application to be processed.

Your Path to becoming a Certified Payroll Manager (CPM)

The CPM certification builds on compliance knowledge and develops payroll management skills to prepare seasoned professionals to manage a payroll department.

Course Requirements

Introduction to Payroll Management (IPM)

Prepares professionals to manage a payroll department by introducing them to the most applicable core management skills. Based on market research, the course provides the management content and tools, such as decision-making and project management, required to be a successful manager. It builds on the foundation of a Payroll Compliance Practitioner's experience, knowledge, application of legislative monitoring and effective communication of payroll programs and policies. IPM is available through post-secondary institutions and online through the Canadian Payroll Association.

Prerequisites: Payroll Compliance Practitioner (PCP) certification and payroll experience.

Applied Payroll Management (APM)

Provides professionals with the opportunity to apply relevant management processes in a payroll department context. Benchmarking, best practices development and human resources skills, such as monitoring, assessing and supervising personnel, are utilized to enable the payroll professional to achieve organizational and career goals. APM is available through post-secondary institutions and online through the Canadian Payroll Association.

Prerequisites: Introduction to Payroll Management

Note: Effective January 1, 2017, CPM students should complete the CPM courses and submit their Certification Declaration within five (5) years of the start date of their first successful IPM course.

The Canadian Payroll Association offers two certifications, the Payroll Compliance Practitioner and the Certified Payroll Manager.

Courses are available at colleges and universities across Canada and where noted, online through the Canadian Payroll Association.
